Message from the President of Tennis Ireland LETTY LUCAS

I am delighted to be given the opportunity to write the foreword for this year's Annual Report for Tennis Ireland – a reflection of the exceptional progress and collective energy that continues to drive our sport forward.

Under the operational leadership of our CEO, Kevin Quinn, Tennis Ireland is making tremendous strides across so many areas of our organisation. From grassroots to elite levels, from governance to community impact, our momentum is unmistakable. I also wish to acknowledge Ronan Reid, our Chair, and the entire Board, who provide strong strategic direction, robust governance, financial stability, and a renewed spirit of collaboration through interbranch forums. Board meetings are purposeful and productive, with a shared commitment to the long-term success of tennis across the island.

We are especially proud that Tennis Ireland remains a recognised role model for Women in Sport. Meaningful progress has been made in developing female leadership, coaching, and participation—this remains a priority as we build a sport that is inclusive and representative at every level.

As was promoted during the US Open last year, tennis is more than a game—it is a proven vehicle for health, wellbeing, and connection. Studies now show that tennis can add up to ten years to life expectancy, while also supporting mental wellbeing and lifelong friendships. These benefits underscore the importance of facility development, and we recognise the need for investment in covered courts—essential in our climate, where over 150 days of the year are typically wet. Steel-framed, weatherproof structures are increasingly cost-effective and should be a consideration for clubs wishing to enhance their playing facilities for their members

This year also marked a bold new chapter for Tennis Ireland with the launch of our rebrand — a project



that celebrates our values and ambition. The rollout will continue in the months ahead, and we are excited about the clarity and unity this will bring to our identity nationwide.

To our extraordinary volunteers: thank you. Your dedication to our clubs, coaching networks, development pathways, and provincial programmes is the heartbeat of everything we do. The growth in our tournament calendar—now approaching the upper limits of what we can accommodate for ITF and Tennis Europe events—is thanks in no small part to your tireless efforts and that of the competitions staff.

Throughout the past year, I have had the privilege of visiting clubs, attending provincial AGMs, tournaments, and awards evenings. These engagements are, without doubt, the most rewarding part of my role. They remind me of the passion, energy and camaraderie that define Irish tennis—and they continue to inspire me to keep reaching out to more of you in the year ahead.

We will continue to work hard to attract sponsorship, develop programmes and support clubs, coaches and players who shares our love for this great sport.

Message from Chairman

RONAN REID

I am delighted with the opportunity to serve as your Chair of Tennis Ireland. I would like to thank my predecessor Paul O'Connor for his positive steering of the Board throughout his tenure. I only joined the board later in the year so much of the 2024 progress was under his excellent guidance.

Our goal in Tennis Ireland as Kevin notes is to give all of you, our tennis community; "the game of your life", The Board, the Tennis Ireland Executive and our army of volunteers are as always focused on an enjoyable tennis experience for all; new memories, more players, better players, more courts and better courts. The launch of our new logo underscores this ambition. Tennis is a great and popular sport; look alone at the success of the autobiography of our Davis Cup Captain, Conor Niland.

2024 was an important year for Irish Tennis. Increased membership numbers, increased numbers in and of competitions, a welcome return of the Irish Open at Carrickmines and wins both in the Davis Cup and the Billie Jean King Cup. The development of Enjoy Tennis and Women in Tennis Programs are central to making our sport more inclusive and more accessible. The continued progress in performance tennis programs combined with the increase in junior international events bodes well for our sport.

When I took over as Chair I looked at the position of Irish tennis versus other countries and while many learnings: one statistic stood out: according to the ITF we have a lot fewer courts per population than other countries. We have one club court per 7,100 citizens versus one court per 3,200 citizen in a sample of 15 similar countries to Ireland or one court per 2,000 when you include larger countries. To grow our sport, improve our sport and ensure it remains inclusive requires more courts; both in existing clubs, new clubs and also the revamp of the many public courts which by number are greater than our number of club courts. This is a longer term project, 5 years+, and is a keen focus of Tennis Ireland.

In 2024 we invested in events, with as mentioned the successful return of the Irish Open and the hosting of the Davis Cup in Limerick to a sell out crowd. We look forward to our home Davis Cup tie versus China later this year. Hosting home Davis Cup ties and international tournaments requires considerable investment and in 2024 represented the main driver of our increase in



expenditure. These are not new initiatives but a return to key events post Covid. To relaunch such events requires investment in the early years and sponsorship and commercial income in the latter years.

We also continue to invest in facilities with commitments made to the Dundalk Tennis Arena together with a generous benefactor. The development of tennis facilities around third level educational facilities is an important development for Irish Tennis; whether the proposed UCD and benefactor funded tennis centre, or the proposed Thurles Regional Sports Campus Project or our current National Tennis Centre in DCU; which we will likely invest in during 2025.

But all of this comes at a cost. This year as a result we saw a decline in our surplus to an almost breakeven level, but we will continue our programme of investment in our sport. Grant funding from Sport Ireland and other sources comprises 31% of our income and matches our club and player capitation fees with the remaining 38% comprising mainly tournament, sponsorship and Performance squad income. Tournament Income and Sponsorship income both represented the highest percentage growth.

As a Board we also have to keep a keen eye to our finances and sometimes make less popular decisions. As noted, we are partially funded in equal amounts by you, our tennis members via your clubs and by the government through Sport Ireland and other grants. Our staff costs grew only by inflation and given the level of activity represented a considerable effort by Kevin and his very dedicated team and I very much thank

them for their work and commitment. I would also like to thank Sport Ireland, Sport Northern Ireland and all our sponsors and benefactors for their continual support for our sport of tennis.

The expense of the organisation, other than staff, whether events, facilities, technology, office costs or our investment in affiliates organisations like Parks Tennis did see increases and as a result, for the first time in a long number of years, we had to increase tournament capitation fees and we will also have consider our level of player capitation fees during

2025. Such decisions are the subject of considerable deliberation and are not made lightly and are necessary so we can continue to invest in and progress our sport.

It would be very remiss of me not to mention two particular greats of Irish tennis that we lost this year and who made very different but equally valuable contributions. Firstly, the great Matt Doyle who helped Ireland scale incredible heights on the international stage. Secondly Kay Lonergan who was the driving force behind the development of Parks Tennis with upwards of 15,000 children participating in their various camps and activities; Kay's legacy will live on for a very long time. We remember them both.

I would like as Chair to thank our Board and all other volunteers for their commitment and time given to the running and development of tennis in Ireland. It could not happen without this immense voluntary effort.

And finally, to you all, our tennis community; wherever or however you play our great sport; a very big thank you for your ongoing support.

Message from

CHIEF **EXECUTIVE KEVIN QUINN**

2024: Continued momentum, collaboration and growth at all levels for Tennis in Ireland.

A busy, productive and satisfying year. With so much work taking place both on and off the court, across the island, 2024 delivered continued positive momentum at all levels for tennis in Ireland. It is particularly encouraging to see so much constructive collaboration between our many important stakeholder groups, both volunteer and staff, united in our shared ambition to sustain and grow our wonderful sport.

Our large and growing tennis community continues to thrive. 2024 saw a further increase of 1.6% in the number of affiliated tennis clubs to 190. In turn, we've seen a corresponding increase in our affiliated members by 9% to 93,807 members. Tennis Ireland is on target to reach our goal of a 50% increase in affiliated members by 2028. Our small, dedicated development team do an excellent job in supporting our clubs across the island. They help promote improvement in critical areas such as governance, safeguarding and sustainability. In addition, they lead and promote the many excellent tennis programmes that run across our provinces, for clubs, parks, schools and universities. I'm delighted to report that 2024 was another consecutive year of growth in both number and participation across all our tennis programmes.

Established in 2015 by Shankill Tennis Club and our Leinster Branch colleague, Liam O'Donoghue, "Enjoy Tennis" is Tennis Ireland's dedicated programme for players with a disability. Working with volunteers, players, clubs, coaches, service providers and advocacy groups, the Enjoy Tennis programme provides an accessible and inclusive environment for people of all abilities to play tennis. In 2024, with the support of Sport Ireland, and working in collaboration with Liam and a small team of energetic and talented volunteers, Tennis Ireland were able to staff the Enjoy Tennis Programme for the first time. I'm delighted to confirm that there are now 166 locations hosting a variety of Enjoy Tennis programmes nationally, with more than 1500 players involved.

Tournaments, both social and competitive, continue to play a central role in enhancing both the sporting enjoyment and experience for all tennis players.

Tournaments also promote social connections, as players meet others with similar abilities and interests, building friendships and nurturing our growing tennis community. Led by our excellent Competitions Team, and working with many outstanding volunteers, 2024 saw another significant increase both in the number of tournaments organised and in the number of players participating. A record 231 tournament permits were issued for the first time which led to an increase of entries of 17% to 39,336 over the year. A sincere note of thanks to all the Clubs and volunteers who hosted and co-ordinated these tournaments nationally.

Tennis Ireland's new National Performance Development Programme was successfully launched and delivered through 2024. Led by our diligent Performance Development team, and supported by the Board through Jerry Sheehan's excellent work, Tennis Ireland introduced a new player-centred approach to player development. Based on new player programmes, tailored to each individual performance player's stage of development and performance goals, Tennis Ireland endeavours to deliver a bespoke National Performance Development Programme to better support each individual player. Holding our first players and parents' workshops has been hugely beneficial to greater collaboration, vital to ensuring that our new National Performance Development Programme continues to improve. Our longer-term ambition is to build a highperformance culture for Irish tennis, for the first time. Sincere thanks to all the players, coaches and parents for their collaboration, advice and input thus far. We're excited to see how this important performance programme will develop and grow over the coming years.



With all this additional on-court action, I'm proud to report that Tennis Ireland delivered on another key objective for 2024, to break even, where for consecutive years we have again delivered a modest surplus. Key to this has been a further increase of 10.8% in our annual revenues. In this regard, I would like to offer sincere thanks to all our partners and sponsors. Your ongoing trust and support is vital to the work we do, supporting and growing our tennis programmes nationally. Thanks also to our Provincial Councils and our hardworking Finance and Communications team at Head Office for their attentive, important work in this critical area.

Through Sport Ireland's excellent work, the Irish Government has demonstrated that it is a strong supporter and promotor of sport for both physical and mental wellbeing. Participation in sport across our island continues to grow, often as a direct result of the various financial supports our Government continues to provide. A note of thanks to former Minister of State for Sport, Thomas Byrne, TD, for his fantastic energy and support throughout his term, and to the broader team in the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media for their excellent support, diligence and advice. A warm welcome also to Minister of State for Sport and Postal Policy, Charlie McConalogue, TD. I'm looking forward to continue working with you.

2024 saw the conclusion of the Government's latest Community Sports Facilities funding scheme, that offers capital grants to sports Clubs to improve their local sports facilities. Tennis Ireland ran a co-ordinated campaign in support of our Clubs to make successful applications to this capital fund. I'm delighted to confirm that through 79 applications, Tennis Clubs received the 5th highest allocation of all sports, receiving a record €7.23m in funding. We look forward to assisting our Clubs, where possible, as they work to increase and improve available tennis facilities over the coming years.

Throughout 2024, the Board and staff of Tennis Ireland worked very closely with Sport Ireland and I must acknowledge Dr. Una May, Paul McDermott, Shane Califf, Brian Staunton, Melanie Lettis and all the Sport Ireland team for their ongoing assistance, advice and support. The increase in core funding, secured from Sport Ireland for 2024, had a real and positive impact on Irish tennis and our all-island tennis community. I would also like to thank Interim CEO Richard Archibald, Colin Atkinson and all the team at Sport Northern Ireland for providing additional funding to support tennis in Ulster, and for their tireless work and support for tennis and all sports across Northern Ireland.

The year-on year growth in all areas of our wonderful sport is a direct result of the excellent work at Head Office to support and deliver many all-island Tennis programmes. Our organisation has continued to grow to deliver new tennis programmes and support

our growing tennis community. To my colleagues at head office and around the country, thank you for your excellent work, energy, skill, drive and passion to improve tennis at all levels. It is enjoyable to work with each of you as we strive to deliver on our purpose – to give everyone the game of their life.

I would like to express my sincere gratitude to former Chairperson Paul O'Connor for his expert support and advice over my first 18 months with Tennis Ireland. Paul set the standard for good governance and along with David O'Beirne was instrumental in introducing our updated and improved constitution. A warm welcome to our new Chairperson Ronan Reid, who has certainly hit the ground running. Together with our Board and our Provincial Councils, Ronan's expertise, drive and passion for Tennis will help our organisation set new levels of excellence. I'm looking forward to continue working with you, and for your valued advice and support. Together I've no doubt we can achieve our shared goals, and continue to drive our organisation, our tennis community and our sport to evolve, improve and grow.

A special note of thanks to former President John Ryan for representing Irish tennis with such distinction and success over his term. In February 2024, John was succeeded by President Letty Lucas from Downshire Tennis Club, outside Belfast. Letty, who many of you will know, has taken to her role with energy and enthusiasm, travelling widely at home and abroad to meet so many of our Clubs and Tennis community. Letty is a fantastic ambassador for Tennis and for Ireland and I congratulate Letty on your success in the role to date and I look forward to continue working with you.

As we look forward into 2025, great work is ongoing by both staff and volunteers at all levels of our sport. Tennis Ireland will have a number of announcements relating to new tennis programmes, new tennis partners, and a new indoor tennis arena, as well as other innovative initiatives aimed to make it easier for people to try, play and enjoy our brilliant sport. We are looking forward to the return of the Irish Open at Carrickmines on July 27th as well as another Davis Cup home tie, Ireland V China, on September 13th/14th. So please continue to watch this space!

Finally, I would like to thank all our brilliant volunteers and the broader tennis community who give so much of their time and expertise, that is absolutely vital to the successful running of our sport. Across our island, to all of you working on the Board, the Provincial Branch Councils, each of our committees, and of course those managing and running our tennis clubs - thank you for your tremendous service and your sustained excellence, through which tennis can and will continue to grow and

REMEMBERING MATT DOYLE AND KAY LONERGAN

Irish tennis lost two remarkable figures this year. Matt Doyle, who passed away at the age of 70, was widely regarded as Ireland's most successful modern-era player. A former world No. 65, Matt competed in all four Grand Slams, reached the last 16 of the US Open in 1982, and won the Cologne Grand Prix in 1983. His greatest legacy, however, was his contribution to the Davis Cup team, where he played a pivotal role in elevating Ireland to Group 1 status and inspiring the next generation of players.

Kay Lonergan, the heart of Parks Tennis for nearly five decades, also sadly passed away. Since 1977, Kay dedicated herself to making tennis accessible to children across Ireland, championing values of inclusion, community, and opportunity. Her tireless commitment and impact went far beyond sport—she was a mentor, organiser, and a transformative presence in Irish tennis. Kay's legacy lives on in every child she inspired and every coach she supported.

We remember them both fondly. May they rest in peace.





OUR GOVERNANCE STRUCTURE

Tennis Ireland operates under the trading name of Tennis Ireland Company Limited by Guarantee. We represent all 32 counties of Ireland and are officially recognised in the Republic of Ireland by the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media through Sport Ireland, and in Northern Ireland by Sport Northern Ireland and the Olympic Federation of Ireland. Internationally, we are affiliated with the International Tennis Federation and Tennis Europe.

In April 2022, we adopted the Code of Governance for Sport, and our Board-appointed Governance Committee is responsible for ensuring ongoing compliance. Oversight of this compliance is provided by Sport Ireland.

Tennis Ireland's core legal framework is defined in its Memorandum and Articles of Association, which govern how the organisation functions as a legal entity.

Board of Directors

The organisation is governed by a voluntary Board of Directors, consisting of ten members elected for a three-year term at the Annual General Meeting (AGM). Our Board brings together individuals with a wide range of skills and experience.

Five Directors are nominated by the Provincial Branches—two from Leinster and one each from Ulster, Munster, and Connacht. In addition, up to five independent (non-representative) Directors may also serve on the Board.

Responsibility for the day-to-day management of the organisation lies with the Chief Executive Officer (CEO) and staff, who are supported by voluntary committees and Provincial Branches. These operate under Terms of Reference approved by the Board.

The Board's primary role, as outlined in the Company's Memorandum and Articles of Association, is to provide strategic direction and oversight. A dedicated Board Terms of Reference and a Schedule of Matters Reserved for the Board clearly define the division of responsibilities between the Board and the CEO.

To uphold good governance, policies are in place to manage conflicts of interest and loyalty. Board meetings are typically held monthly, with all relevant papers circulated at least five days in advance to ensure Directors have sufficient time to review and prepare.







OPERATIONAL REVIEW

Relationships

Sport Ireland

Sport Ireland is a key stakeholder in our organisation, and we greatly value the ongoing support and collaboration with their dedicated team, led by Dr. Úna May. We engage with Sport Ireland regularly and appreciate their commitment to the development of tennis in Ireland.

In 2024, Tennis Ireland secured significant investment from Sport Ireland with awards of:

- €735,000 in Core and Performance Development Funding
- €80,000 in Women in Sport (including €10,000 for the Racquet Sports Collaborative Project)
- €265,000 in Dormant Accounts Funding (over Equity, Diversity and Inclusion, Her Moves, and the Local Disability Sports Fund)
- €65,000 in Special Projects Funding for the Davis Cup and participation in the IBSA World Games

Sport Northern Ireland

We also benefitted from an award of £52,000 in Sports System Investment from Sport Northern Ireland.

Federation of Irish Sport

The Federation of Irish Sport is the representative organisation for the National Governing Bodies of Sport (NGBs) and Local Sports Partnerships (LSPs) in Ireland. There are regular engagements with the Federation across several areas including the provision of workshops and training, attendance at its annual conference and the facilitation of a joint approach to lobbying government for additional funding for Irish sport.

International Tennis Federation

The ITF continue to be a key partner of Tennis Ireland and we have cultivated a great relationship with its management team and regularly engage with them in relation to the ITF World Tour, Davis / Billie Jean King Cup, their online coach education portal or through our close involvement with them in the development of the World Tennis Number.

Tennis Europe

We also engage regularly with Tennis Europe who support the delivery of the Tennis Europe Tour and who also act as a conduit for the distribution of ITF support. We work closely with the Development Officer for Europe, Vitor Cabral who regularly engages with us and guides our actions, particularly when it comes to development activities.

Local Authorities

Local authorities continue to be a key partner for Tennis Ireland and our Clubs. The local authorities provide land for club developments, support for capital projects and funding for the delivery of many programmes.

Throughout the year, we maintained strong partnerships with several Local Authorities, including Belfast City Council, Fingal County Council, Dún Laoghaire–Rathdown County Council, Cork County Council, and Dublin City Council, among others. Our Development Officers continue to collaborate closely with Local Sports Partnerships, Government agencies, and clubs to support applications for available small grants.

Fingal County Council remains a key supporter of tennis development in the region. They co-fund the position of our Development Officer, Tara Congdon, and provide vital seed funding for initiatives such as the Community Adult Programmes, Primary Schools Tennis Programmes, Transition Year Leadership Training, Teacher Training, Parks Tennis, and Club Support Grants. These contributions play an important role in enhancing local programmes and supplementing club fundraising efforts. COVERNANCE, CULTURE, PEOPLE AND CAPABILITIES

Covernance

The Governance Committee of Tennis Ireland plays a vital role in ensuring that the organisation has the appropriate policies, procedures, and structures in place to support the Board, Executive, and volunteers in effectively delivering the organisation's strategic goals.

A key reference for the Committee is the Sport Ireland Governance Code for Sport, which outlines 75 recommended practices that organisations like Tennis Ireland are expected to meet. Ensuring alignment with this Code remains a standing priority. The Governance Committee will continue to monitor progress and lead efforts to embed a culture of integrity, accountability, and continuous improvement at every level of the organisation.

People and Capabilities

In 2024, we made significant strides in strengthening our organisational capacity and investing in staff development. The organisation experienced a 20.7% year-on-year increase in employee numbers, rising from 29 in 2023 to 35 in 2024. This growth reflects our continued investment in building organisational capacity to support strategic priorities, enhance service delivery, and strengthen operational resilience. This growth also aligns with the implementation of our broader workforce strategy, which focuses on attracting high-calibre talent, fostering a diverse and inclusive workplace, and investing in the development of our people. By increasing our capacity, we are better positioned to deliver on our strategic goals, respond to emerging opportunities, and drive innovation across the organisation.

A comprehensive organisational review was completed towards the end of 2024, resulting in ten key recommendations aimed at enhancing performance and driving continuous improvement across the organisation. We are actively progressing the implementation of key recommendations, with a strong emphasis on delivering tangible outcomes.

Learning priorities were shaped by staff surveys and the organisational review, ensuring training aligned with identified needs. To support professional development, we launched the Give Learn platform, a new online learning and development platform, providing all employees with access to targeted training and growth opportunities anytime, anywhere.

A comprehensive organisational review was completed towards the end of 2024, resulting in ten key recommendations aimed at enhancing performance and driving continuous improvement across the organisation. We are actively progressing the implementation of key recommendations, with a strong emphasis on delivering tangible outcomes.

This has been a pivotal step in embedding a culture of continuous learning. Individual development remained a key focus, with staff completing specialised training in areas such as employment law, mentoring, and equality, diversity, and inclusion. Many also took part in Sport Ireland programmes, supporting ongoing growth and leadership across the organisation. In response to skill gaps, Microsoft Excel training was provided to all staff, and mandatory manual handling training was delivered to promote safe workplace practices. These initiatives reflect our continued investment in people and our commitment to building a strong foundation for future performance and innovation.

Throughout the year, four in-person staff meetings were held, supporting collaboration, knowledge sharing, and team cohesion. Looking ahead, we remain focused on creating a work environment that supports professional growth, encourages collaboration, and reinforces our values.

COMMUNITY, CLUBS AND COMPETITIONS

Safeguarding

Safeguarding remained a top priority across all regions.

Our Development Officers worked with the clubs on compliance levels with our safeguarding requirements.

Multiple safeguarding meetings were held nationally and regionally, with active participation from our clubs.

The clubs were presented with the requirements and signposted towards how to access training and further resources on the subject.

Safeguarding officers are present in all our affiliated clubs, with an average of 380 officers across the clubs.

Vetting

In the Republic of Ireland, Garda Vetting is conducted by the National Vetting Bureau and is a legal requirement for individuals working with children or adults at risk.

Organisations registered with the Bureau submit vetting applications on behalf of individuals.

The process checks for criminal records and any information that may be relevant to a person's suitability to work with vulnerable groups.

Garda Vetting is not a police clearance certificate, but a disclosure of relevant information held by An Garda Síochána.

In Northern Ireland, Access NI is the body responsible for criminal record checks.

It operates under the Department of Justice and offers three levels of checks, basic, standard, and enhanced, with the enhanced check being required for roles involving regulated activity with children or adults at risk.

Enhanced checks may include information from the police and relevant barred lists.

Applications are typically made online through registered organisations or umbrella bodies authorised to process them.

How do both vetting systems apply specifically to tennis in Ireland?

In the Republic of Ireland, anyone involved in tennis who works with children or adults at risk such as coaches, volunteers, officials, or club committee members, is required to complete Garda Vetting through Tennis Ireland.

This process helps ensure a safe and protective environment across clubs by checking for any relevant criminal history. Clubs must be affiliated with Tennis Ireland to access the vetting service, and individuals must complete a form and online process before taking up their role.

In Northern Ireland, tennis coaches, volunteers, and others in regulated roles must undergo Access NI Enhanced Disclosure checks through Tennis Ulster. This ensures individuals working with juniors or participants at risk are properly screened.

Like in the Republic, this is a vital part of safeguarding in tennis and supports a commitment to creating a welcoming, safe environment for all players.

We need to be mindful, however, that vetting is only one area of recruitment and committees should conduct reference checks and at the very least, an informal interview for all those working with children or adults at risk.

In 2024 Tennis Ireland processed 1,032 vetting applications and Tennis Ulster processed 71 Access NI Checks

Vetting Application Form Submissions - Important

We would like to kindly remind our affiliated members who require vetting to take extra care when completing their application forms. Each month, we receive a significant number of forms and nearly 30% are submitted with incomplete or missing information. This not only delays the vetting process but can also result in additional administrative steps.

Community Tennis

Strong collaboration occurred during the year with Local Sports Partnerships and councils to deliver inclusive tennis opportunities -

Try Tennis and Women in Sport Initiatives were hosted in multiple regions with 533 participants throughout the regions and 250 teenage girls involved in the exercise/energise programme.

Older adult programmes (Sport for Life) were delivered in Fingal with 137 participants.

Community Events included European Week of Sport, family days, flag week, and multi sports festivals.

360 participants were involved in the Malahide Sports Showcase.

The team collaborated with parks tennis to assist with participation growth.

Schools Tennis

Schools' Tennis saw significant nationwide engagement in 2024, driven by our Schools Coordinator and Development Team. A total of 22,415 children and teenagers across both primary and secondary levels participated in tennis activities.

The National Schools Club Link Programme alone reached 19,838 primary students across 141 schools, while 1,294 secondary school students took part in dedicated sessions. Additionally, 177 teachers nationwide participated in tennis-focused training programmes to support ongoing delivery in schools.

The Transition Year Leaders Programme with strong school support, empowered students to lead school and club sessions with 850 Transition Year students trained across all provinces.

The participants were encouraged to pursue further introductory programmes like our Play and Stay Assistant programme and the level 1 coaching course.



Parks Tennis

Parks Tennis, a not-for-profit organisation and partner of Tennis Ireland established in 1977, continues its mission of making tennis accessible and affordable to children aged 5-17 from all backgrounds across Ireland. After the significant challenges posed by Covid-19, which saw participant numbers drop from 15,602 in 2019 to just 2,336 in 2020, the organisation has worked diligently to rebuild. In 2024, participation increased by 16% compared to the previous year, with 9,628 children taking part in 57 locations nationwide. This growth was driven by the introduction of new venues, reintroduction of previous ones, and a targeted school outreach campaign delivered in conjunction with the Tennis Ireland Development Officers and the Schools Tennis Coordinator. In Dublin, 225 leaders and assistants were deployed across four terms. Strong growth was also seen in counties such as Carlow, Cork, Galway, Kildare, Monaghan, Sligo, Wexford, and Wicklow.

Tennis Ireland wish to acknowledge and commend the outstanding work of Cormac O'Shea and Peter Farrell, whose leadership and tireless efforts have played a crucial role in the resurgence of Parks Tennis.

Thanks to Cormac and Peter's commitment, the programme is well on its way to returning to the strong participation levels seen before the pandemic.

We would also like to extend our thanks to clubs, local sports partnerships, councils, sport Ireland and schools for their continued support.

We were deeply saddened to learn of Kay Lonergan's passing on Sunday 30th March 2025, who was the bedrock of Parks Tennis since its inception in 1977. For 48 years Kay dedicated herself to the programme, and her home became the hub, headquarters and central warehouse for Parks Tennis. Parents, coaches, staff and children all descended on 142 Vernon Avenue at all hours of the day and night. All of this seemed normal to her children Adrienne, Trevor, Catherine and Ralph and her late husband Joe. She even managed to "cajole" all of them into helping with and working for Parks Tennis! Kay's passing is a huge loss to her family, friends and to the tennis community in Ireland. Hundreds of thousands of children and thousands of leaders and assistants have been touched and inspired by Kay's energy, dedication, selflessness and kindness.

Kay's legacy lives on through the thousands she touched, and she will be sorely missed. May Kay's amazing soul rest in peace.

Club Development

Throughout 2024 our team of Development Officers visited 154 clubs, providing advice on a variety of topics like safeguarding, governance, development plans, funding and indeed, any general enquiries pitched their way. The team delivered six online forum topics across all regions including – court surfaces, junior programmes, supporting small clubs, club management systems, enjoy tennis, and sustainability. The forums were engaging and sparked valuable discussions, with the 115 participants sharing best practices.

Club-Mark Accreditation

Tennis Ireland Club-Mark is a three-tier (Bronze, Silver, Gold) accreditation programme that recognises well-managed, inclusive, and high-quality tennis clubs. The programme supports clubs in improving operations, governance, safety, coaching, equality, outreach, sustainability and member experience. Accredited clubs receive recognition, promotional benefits, and resources to grow and retain membership.

To date, 53 clubs across the country have earned Tennis Ireland Club-Mark status. In 2024 alone, 15 clubs achieved accreditation, as detailed below:

Tennis Ireland Leaders Course

The Leaders Course is a two-hour programme focused on organised play and level-based competition. Its objective is to empower club volunteers to run fun, inclusive playing sessions and structured multimatch format competitions tailored to different levels of play.

In 2024, our team delivered courses in Wexford, Ballypatrick, Fountainstown, Nenagh, Trim, Mullingar, and Athlone, with a total of 71 participants.

We have also developed an online Activators Course, which is open and free to all. It serves as a support programme for those who have already completed the Leaders Course or as a preparatory step for those planning to take it. The online course will be available from mid-2025.

Community coaches' recruitment and education

Significant focus was placed on recruiting introductory coaches to deliver our community programmes. To support the objective, we delivered the following programmes. 7 Level 1 Coaching Courses were delivered across all regions involving 84 participants.

Schools Workshops for coaches were delivered in Connacht, Fingal, and Munster for 34 coaches.

Mentoring and shadowing opportunities were offered for newer coaches, especially those in schools.

Sustainability & Environmental Awareness

Sustainability was integrated through pilot club programmes and education. Galway LTC, Kinsale TC, Carlow, Greystones, and St Marys in Donnybrook led pilot schemes. Our Development Officers participated in Climate Action and the GAA Green Clubs workshop.

Educational initiatives included student-led ecoprojects (e.g., book/clothes swaps in North Leinster).

Women in Tennis programme

The Women in Tennis Programme received €70,000 of funding in 2024 from Sport Ireland, with further progress achieved in 2024 to support girls and women in Ireland on and off the tennis court.

In line with Sport Ireland's Women in Sport Policy 2023, the four key areas of focus are active participation, coaching and officiating, leadership and governance and visibility. There have been several key achievements in 2024, detailed below.

Women's Try Tennis

The Women's Try Tennis Programme is a participation programme aimed at beginners and those who haven't played tennis in several years. The programme takes place over 4–8 weeks and is delivered by a licensed Tennis Ireland coach. By the end of the programme participants have learned the basic shots of tennis, can rally with each other, and feel confident to join a local tennis club to continue playing. Tennis Ireland offer funding towards the programme and a club or LSP also typically contribute funding to keep the cost as low as possible for participants.

In 2024, 40 Women's Try Tennis Programmes took place in various locations across the country, with 437 participants taking part in the programme. Of those participants, 68% subsequently joined a tennis club or continued playing tennis on community courts. Female Officials

In 2024, 27 women completed officiating courses through the newly established Tennis Ireland Officials (TIO). As the ongoing implementation of the officiating pathway is rolled out, we will encourage and support more women complete officiating courses and help to develop officiating excellence across the sport.

Female Coaches

In 2024, 60 women completed tennis coaching courses. Fifty-four women completed a Level 1 course, and six women completed a Level 2 course. Tennis Ireland provided over €10,000 in financial support to female tennis coaches by offering partial reimbursements of course fees, once the coaches had become qualified and licensed. As coaching is a key pillar of the Sport Ireland Women in Sport Policy, we have continued this funding support in 2025.

Court Bosses

The Court Bosses programme equips teenage girls between the ages of 16–18 with a Level 1 tennis coaching qualification, as well as tailored empowerment and personal development training. This pilot programme was rolled out in Ulster, in May 2024, and was officially launched by Letty Lucas (President of Tennis Ireland), Kevin Quinn (CEO of Tennis Ireland), and the Court Bosses Project Team of Nuala Phillips, Lisa Strutt, Sinéad Sharkey-Steenson, Michelle Daly Hayes, Sara McCracken, Stephen Garvin and Aoife O'Sullivan in Hilden Tennis Club in June 2024.

Women in Racket Sports Programme

Tennis Ireland

Annual Report 2024

The Women in Racket Sports Programme was developed in collaboration with Tennis Ireland, Table Tennis Ireland, Badminton Ireland, and Irish Squash to support female coaches from all four sports. In April 2024, these National Governing Bodies held a Women in Racket Sports Day in Carlow Lawn Tennis Club. Female coaches from all four sports came together to network and share their experiences with one another. Guest speaker Chloe Magee spoke about her own experience of transitioning from an elite athlete to a coach.

The latter half of the day focused on active participation in which 75 girls and women had the opportunity to try all four of the sports in Carlow Lawn Tennis Club. The aim of the day was to showcase our sports and encourage participants to join their local clubs. In 2025, this Women in Racket Sports Day took place in Galway Lawn Tennis Club to coincide with International Women's Day.

Billie Jean King Cup Roadshow

In June, members of Ireland's Billie Jean King Cup Team attended St Olaf's National School for a meet and greet session with pupils before the tournament in Moldova. The pupils got to meet several players including Sinéad Lohan, Sarah Hawkshaw, Olwyn Ryan–Bovey & Shauna Heffernan, and also had the opportunity to pick up some tennis tips from coach Orla Wright. This event was extra special as Sinéad Lohan is also a teacher in the school! A similar event is planned in advance of the 2025 Billie Jean King Cup.



Serve Swap

Serve Swap is Tennis Ireland's dedicated Her Moves programme. Her Moves is a Sport Ireland initiative that is designed to inspire and support more teenage girls to be active.

It aims to empower all teenage girls, building confidence and providing motivation to find something that gets teenage girls moving. Serve Swap combines the elements of social tennis and sustainability by providing free tennis lessons and encouraging participants to swap pre-loved items with one another. Women in Sport Week 2024

In line with Sport Ireland's Women in Sport Policy, the theme for Women in Sport Week 2024 was active participation. Across the week over 450 primary school girls attended a Try Tennis session in the National Indoor Arena; 75 secondary school girls attended a Try Tennis Day in the National Tennis Centre; and 30 women availed of low-cost tennis lessons in the National Tennis Centre.

Enjoy Tennis

Enjoy Tennis is Tennis Ireland's dedicated programme for players with a disability. It was established in 2015 and aims to provide fun, safe and supportive environments to learn and play tennis. We collaborate with players, clubs, coaches, service providers and advocacy groups to provide an accessible and inclusive environment for people of all abilities to play tennis. There are now 166 Enjoy Tennis programmes across the island of Ireland with more than 1541 players.

The Enjoy Tennis programme caters for players with an intellectual disability (ID); with autism; with an acquired brain injury (ABI); who use a wheelchair; who are blind or visually impaired; who have dementia; who are deaf or hard of hearing; who have cerebral palsy; who want to improve their mental health; and who have a physical disability but do not use a wheelchair (para-standing tennis).

In 2024, Tennis Ireland were awarded €50,000 for this disability programme through the Dormant Accounts Fund. Tennis Ireland allocated €175,000 to 70 tennis clubs nationwide through the Local Sports Disability Fund. Every club could apply for a maximum of €3000, with all clubs being awarded their requested value of funding. Many new Enjoy Tennis groups were established, and clubs were able to purchase specialised equipment and collaborate with licensed tennis coaches to deliver programmes. Summer camps, inclusion days and fun days were also organised to provide participants more opportunities to engage with the Enjoy Tennis programme. Tennis Ireland's regional development officers work closely with clubs and service providers to roll-out the Enjoy Tennis programme nationwide.

Coaching

One of Tennis Ireland's main goals is to increase and maintain the development of quality coaches working in the field. To achieve this objective, we work very closely with Sport Ireland Coaching, the International Tennis Federation, and Tennis Coach Ireland.

The Coach Development Team consists of a panel of Coach Developers (Tutors) and Assessors who have all gone through five weekends of Training with Sport Ireland Coaching and further tennis specific training through attendance and shadowing on Tennis Ireland

Courses as well as CPD training with Sport Ireland and the ITF. We currently have 7 active Coach Developers who have delivered courses over the last 4 years under the new Coach Education system. We also have an international expert, Hrvoje Zmajic who is a highly regarded expert worldwide.

We currently hold the ITF'S Gold Recognition of National Coach Education Systems for the 2021 – 2025 period and we are affiliated with the ITF Academy where we have four levels of coaching as outlined in the text below.



Wheelchair Tennis Coaches Workshop with Stuart Wilkinson, Shankill Tennis Club

Level 1 - Play Tennis Course

The goal of the Tennis Ireland Level 1 course (PT Course) is to help participants understand how to introduce tennis to beginner players of all ages and organise and deliver tennis sessions in a fun and effective learning environment in Schools, Parks, Clubs and anywhere a tennis court or micro/mini courts can be set up.

Level of play required – World Tennis Number (WTN) 35 to 40

Level 2 - Coaching Beginner to Intermediate Players Course

The goal of the Tennis Ireland Level 2 course (CBI Course) is to provide the participants with the skills required to promote tennis at a grass-roots level, introduce participants to tennis through the modified courts, to coaching players up to junior and senior internal club competition level.

Level of play required - WTN 25 to 35

Level 3 - Coaching Advanced Players Course

The goal of the Tennis Ireland Level 3 Course (CAP Course) is to provide participants with the competencies to teach tennis to intermediate and advanced players involved in open regional competition and leagues

Level of play required - WTN 15 to 25

Level 4 - High Performance Course

The goal of the Tennis Ireland Level 4 Course (HP Course) is to prepare coaches to work with advanced players and those striving to become professional players involved in National & International competition.

Level of play required - WTN 15 and better.

Courses delivered in 2024

We delivered 9 Level 1 courses in 2024. One in Connacht, two in Munster, two in Belfast and four in Leinster, with 114 participants involved in total. Over the course of the year, 62 candidates qualified at Level 1 from various courses since the introduction of the new system in 2021. A survey was conducted in 2024 to discover the barriers to candidates qualifying with 71 responses. A Level 1 refresher session was planned and delivered in February 2025 to address these barriers and assist candidates in becoming qualified.

From October to November, we delivered one Level 2 course in West Wood Leopardstown with 12 coaches involved. 7 of these coaches have since become qualified as Level 2 coaches.

Play and Stay Assistant Programme

The Play and Stay Assistant Programme which is a non-award introduction programme for participants who wish to assist qualified and licensed coaches. The programme is suited to applicants aged 15 or over and has proved to be popular amongst teenagers and those interested in completing the Level 1 Play Tennis Course in the future.

In 2024 a total of 109 applicants registered for the programme.

Sport Ireland Tutor Training

We have one coach currently on the Sport Ireland 2024 Coach Developer course nearing the end of their training with a further three applications submitted for training in 2025. This increase in Coach Developers will assist with the demand for delivering courses across Ireland at all levels and improve the standards for coaching in Ireland.

ITF Academy

The ITF Academy is an online learning platform with a host of Educational Resources which facilitates our Coaches to amass a portion of their Annual CPD points. We pay the ITF Academy an annual fee to the value of €50 which gives Licensed Coaches free membership to iCoach on the ITF Academy from March 2024 – March 2025. All 2024 Licensed Coaches received a code to access content delivered by global experts on iCoach.

The use of appropriately trained coaches

Using unqualified coaches for certain tasks or indeed, working with players beyond what the coaches have been trained to deliver, could have implications for clubs and other stakeholders around safeguarding, or insurance. It is important that all individuals or organisations who employ or contract coaches, (e.g., clubs, schools, parks, parents, and players), use the services of licensed coaches only. We would like to remind readers that Licensing is one of our safeguarding requirements under "recruitment".

Licenced Coaches and Continuous Professional Development - CPD

The objective of our Licensing Programme is to ensure our coaches are up to date with all the statutory requirements around safeguarding, they keep themselves up to date in CPD, have registered with Tennis Ireland and are working at the appropriate Level for what they are trained.

The licensing scheme runs on an annual basis from January 1st to December 31st of the year in question with registration opening mid-December to allow for coaches to obtain their license in advance of the new year. Clubs and other stakeholders employing coaches, should ensure they conduct checks on the expiry dates of the verification documents produced for safeguarding training, safeguarding refreshers (if applicable), vetting, and provide evidence that they have achieved the necessary CPD points to ensure coaches are compliant.

In 2024 we had 365 licensed coaches and a further 4 applications with no license issued due to not meeting the licensing requirements. We would also like to remind our members that, our safeguarding policies and procedures highlight the importance of using appropriately qualified and licensed coaches. Please refer to our coaching pathway above to understand what each level of coach is qualified to do.

Clubs wishing to know the Level of a particular coach and if they are licensed, can check the Tennis Ireland website under coaching and licensed coaches.

Tennis Coach Ireland

Tennis Coach Ireland's main function is to inform and represent the Irish coaches on all matters related to teaching and developing the game. There are over 300 coaches registered with our Coaches Association TCI.

Tennis Ireland and Tennis Coach Ireland work closely together in areas like our licensing scheme where TCI manage the CPD part of the scheme and the NGB provide support to the association through an annual grant towards their operations and further support through the provision of free membership to the ITF Academy for all Licensed Coaches. It's also important that clubs work closely with their coaches and involve them in the club's plans and provide more security for the Profession by having written terms and conditions agreed between both parties.

With coaches needing 100 CPD points, TCI either approved or organised 21 events making a total of 465 points available to coaches for 2024. As members of the ITF Academy subsidised by Tennis Ireland, coaches had lots of opportunity to amass further points.

Other opportunities were through safeguarding and first aid courses as well as self- nominated Events that were recognised for CPD.

- The TCI Annual Conference took place during the final weekend of September, drawing almost 300 coaches keen to gather insights from an array of international speakers covering diverse topics.

COMPETITIONS

Tournaments

Tennis Ireland grants tournament permits to affiliated clubs to host open tournaments in Junior (18 and under), National Tour, Masters (30+), Blind and Visually Impaired, and Wheelchair categories. We sanctioned 231 tournaments across these categories with the 2nd National Junior Wheelchair Championships in July 2024 and the 5th National Blind and Visually Impaired Championships being held also.

There were a record 39,336 entries into Tennis Ireland tournaments in 2024, a 5,339 or 17% increase on 2023 and a 11,386 or 41% increase since 2022. Every province saw an increase in entries, Leinster tournaments had 16,912 entries (+20% on 2023), Munster tournaments had 15,779 entries (+8% on 2023), Ulster tournaments had 4,407 entries (+23% on 2023), and Connacht had 1,898 entries (+24% on 2023)

For 2025 and 2026, we would like to continue to see and expand as many entry level tournaments being run by clubs to cater for local players. The lowest category T100 tournaments don't require a permit if they are run as a standalone event and would be a great way to attract new players for a social multimatch, fast scoring format that could be run in one day (4 matches) at both Junior and Senior level.

In 2024, we held a record number of 17 International events, 6 ITF U18 events at the National Tennis Centre, Windsor LTC and Naas LTC, as well as Tennis Europe U14 and U12 events being held across the National Tennis Centre, Donnybrook, Belfast Boat Club, Ballinlough, Greystones, Waterford and Shankill. We also held International Masters Events which are proving extremely popular also. These events have been fantastic for our players to have opportunities to gain valuable experience and ranking points on home soil and this is reflected in the increase of the number of ranked players in the Tennis Europe and ITF Junior Rankings.

This culminated in the return of the AIG Irish Open 15k

event, which was kindly hosted by Carrickmines Tennis Club and was a roaring success, with the head of ITF Officiating being the Referee and giving us superb feedback. All the Irish players loved competing at this level and we aim to return in 2025 to Carrickmines with the long-term plan to hold multiple 15k events back to back.

One of the largest projects this year was Officiating and bringing us up to a level of professionalism and accrediting and certifying all our officials, from off court helpers to Referees and Umpires. When I attended my International Referee School in Amsterdam in December 2022, I was astonished by Ireland's positioning in qualified International Referee and Chair Umpires. At that moment in time, we had 1 White Badge Referee (Maria Kilkelly) and 1 Gold Badge Umpire (Fergus Murphy) placing us joint last in Europe at number of Officials. Back home in Ireland, we had no real accreditation for Referees meaning anyone in theory could run a tournament in Ireland with no qualification and experience which led to a number of inconsistencies in practice and in rulings. Now at the end of 2024, we sit with 5 White Badge International Referees instead of 1 which keeps the costs of home international tournaments as low as possible and with 126 Provincial Referees and 13 National Referees. We aim to increase the number of Chair Umpires across the country in 2025 with courses run at provincial level as well as National level with the supplementation of online courses to help all volunteers at tournaments.

This is all supplemented by an Online Portal which will house all our learning materials and online courses in 2025 and give officials a place they can log their work record, receive CPD and be in contact with other officials. If you are interested in getting into officiating, please get in contact.

Tournament Planner

We continue to improve our Tournament Planner Platform through direct collaboration with Visual Reality. This software is a vital infrastructure asset

for Tennis Ireland and our clubs both for Open and Club events. We introduced Tournament Permit online applications since 2023 which has made setting up a tournament easier than ever as you enter the code and your tournament and all the events you applied for are already set up. It will help to keep consistency across the naming of all events run as part of sanctioned tournaments.

The ITF World Tennis Number

During 2024, all sanctioned Open Tournament results recorded onto tournamentsoftware.com were automatically uploaded to the World Tennis Number system. This will ensure accurate Singles and Doubles World Tennis Numbers for all players who compete in Tennis Ireland Tour events.

The World Tennis Number system is also designed to support casual and club-based play. Results from internal Club events and Box Leagues run using ti.tournamentsoftware.com (must include player TI PIN) are uploaded into the World Tennis Number database. In 2025, we intend to start using WTN for seeding in Adult tournaments with the hope for 2026 that we can use WTN for grading into adult tournaments, something the player feedback forms have been asking for a while.

Irish Junior Open

The Junior Lawn Tennis Championships of Ireland this year again kindly sponsored by William Fry is always a highlight of the Irish Tennis Calendar. The event was held from 16th-24th August. It was great to be able to watch the best players in the country compete and as always huge credit to Fitzwilliam LTC for putting on a superb event. 472 players entered 20 events, playing

a total of 543 Matches. In the Boys U12, second seed Max Naughton beat third seed Aidan Garcia Seeber 6/1 6/1. In the Girls U12 number 1 seed Aryia Pringle Quinn triumphed against fourth seed Lily O'Shea 6/2 6/2. In the Boys U14 final, number 1 seed Patrick Breen won in 3 sets against second seed Brody Lee Stafford in a titanic battle 4/6 7/5 6/1 while in the Girls U14, second seed Sienna MacCarthy won in straight sets against top seed Laura Carvalho 6/3 6/0, the second year in succession she took out a number 1 seed in the final. In the Boys U16 number 1 seed Zac Nauahton ended Daniel O'Leary's epic 6 match unbeaten run from qualifiers to triumph 6/2 6/0. In the Girls U16, top 2 seeds Jenny Marsh and Lydia Brennan battled it out in an epic 3 set tussle with Jenny prevailing 5/7 6/3 6/1. In the Boys U18, second seed Sean O'Nuallain won the title this year, defeating number 1 seed Patrick Marsh 6/1 6/4 in the final. Finally, in the Girls U18 event it was another 1st against 2nd seed with Rachel Deegan taking down Chloe Collins 6/1 6/1 to take home the coveted title. We would like to say a big thank you to William Fry for their continued generous support of this event and Irish tennis and to Fitzwilliam Lawn Tennis Club for their hard work in the lead up to and throughout the week.

FINANCE, COMMERCIAL AND COMMUNICATIONS

Marketing and Communications

2024 marked a significant milestone for Tennis Ireland, with the appointment of the organisation's first dedicated Marketing & Communications Officer . This new role brought a more strategic, coordinated, and data-led approach to how we engage with our members, clubs, and the wider public.

The primary focus this year was to lay strong foundations, while driving awareness, participation, and membership growth across all demographics. In tandem with a modest increase in competition fees — the first adjustment in a number of years — our marketing efforts were geared towards reinforcing the value of being part of the Tennis Ireland community.

The 2024 campaigns were the most ambitious and targeted to date. While drawing inspiration from previous membership drives, this year's approach was shaped by fresh insights, updated creative, and a clearer segmentation of our audience.

Over the course of nine months, we activated a wide range of touchpoints including social media, email newsletters, website features, and club-facing communications. Messaging was carefully crafted to resonate with distinct audience groups — from competitive players and casual participants to young players, parents, and lapsed members.

The efforts reflect the growing appeal of tennis in Ireland and the early impact of a dedicated marketing and communications function is one that will continue to evolve and strengthen in the years ahead.

Brand Refresh


One of the most significant milestones in 2024 was leading the development and delivery of Tennis Ireland's new brand identity — the first comprehensive refresh in the organisation's history.

From the outset, the goal was to create more than just a new logo. We wanted a brand that truly reflected who we are as a national body: inclusive, ambitious, and focused on giving everyone the game of their life. Working in partnership with Ringers Creative, Tennis Ireland helped steer a process that was grounded in research, driven by purpose, and shaped by the voices of our community.

The refreshed identity — launched publicly in April 2025 — introduced a vibrant new look and feel that puts the joy of tennis at its core. It was important to us that this wasn't just about visual change, but about deepening our emotional connection with players, clubs, and fans across all levels of the game.

As part of the rebrand, we also renamed our four provincial branches to Tennis Connacht, Tennis Leinster, Tennis Munster, and Tennis Ulster — a move that places the sport front and centre, and brings clarity and consistency to how we communicate nationwide.

It's been especially rewarding to see how well the refreshed identity has landed — both internally and externally. The feedback from clubs, partners, and players has been overwhelmingly positive, and it's already playing a key role in how we position our programmes, grow participation, and tell our story in a more unified and engaging way.



Email Marketing Performance

Tennis Ireland

Between August 1, 2024, and January 31, 2025, Tennis Ireland's email marketing programme delivered 164,222 messages affiliated players across the country. These campaigns played a key role in promoting events, sharing updates, and strengthening the organisation's digital touchpoints.

Our average open rate during this period was an impressive 65.3%, significantly above industry benchmarks and reflective of both a highly engaged audience and well-targeted content. The click-through rate (CTR) stood at 4.5%, indicating a healthy level of interaction with our calls to action — from tournament sign-ups to news and blog engagement.

The unsubscribe rate was just 1.4%, demonstrating consistent value in our communications and a strong alignment with subscriber interests.

This performance was driven by strategic segmentation, improved email design, and the integration of campaign insights from other channels including social media and the website. These results also underscore the importance of our growing subscriber database as a core engagement asset for the organisation.

Digital Performance

2024 saw strong digital momentum across all of Tennis Ireland's key platforms, with social media growth, greater audience engagement, and improved website traffic — all driven by a new, more strategic approach under the leadership of our first dedicated Marketing & Communications Manager.

Social Media Highlights

Across Facebook and Instagram, total video views exceeded 3.1 million, with Tennis Ireland content consistently reaching broad audiences throughout the

- Facebook recorded 1.6M views, 179.2K reach, and 21.5K content interactions. Despite a decrease in reach (-76.4%) and content interactions (-18.5%)compared to the previous period, link clicks were up by 12.8%, highlighting stronger engagement with key calls to action.
- Instagram saw a particularly strong performance, with 1.5M views, 81.9K reach (↑13.7%), and 12.9K content interactions, which doubled year-on-year (\uparrow 100%). Link clicks soared by 140.5%, reflecting the success of more engaging and channel-tailored content.
- Follower growth: Facebook added 634 new followers (√62.3%), while Instagram gained 1.5K

Celebrating Ireland's Blind & Visually Impaired Tennis **Team**

In October 2024, Tennis Ireland was proud to celebrate the achievements of Ireland's Blind & Visually Impaired Tennis Team following their success at the World Championships in Poland. The celebration, hosted at the Sport Ireland Campus, brought together players, families, volunteers, and key figures from the wider sporting community.

The event recognised not only the team's performance - including standout moments like Riya Devereux's double bronze and Babs Weiberg being named tournament MVP — but also the inclusive spirit that underpins our Enjoy Tennis programme. Speeches from Dr. Una May (Sport Ireland), Joe Geraghty (Vision Sports Ireland), and George Lucas (Sport Northern Ireland) highlighted the critical role of collaboration, accessibility, and volunteerism in driving the sport forward.

This celebration marked an important milestone in our commitment to making tennis a sport for all. We remain dedicated to supporting blind and visually impaired players through inclusive programmes, national visibility, and year-round opportunities to compete and grow.

Supporting the Next Ceneration

Tennis Ireland's commitment to growing the game at youth level was reflected in key initiatives during 2024, including the launch of the AerCap TI Junior Kids Programme and the continued rollout of the National Performance Development Camps.

Tennis Ireland

Marketing played a supporting role in both, helping to capture and share the energy of these moments through our digital channels. A photographer was arranged to document the launch and development camps, with the images used across social media and web to promote participation and celebrate the players involved.

These efforts contributed to a wider strategy of making the sport more visible, welcoming, and inspiring for younger audiences.

Committed to making tennis accessible to everyone, we continued to develop relationships with county councils and local sports partnerships nationwide to deliver community driven programmes through innovative initiatives in schools, parks, and local facilities. In addition to Beckett Park in Cherrywood, we also established more community courts in St. Catherine's Park in 2024 and rolled out programmes in various other locations.

Continuing our Enjoy Tennis programme, we were able to further provide inclusive tennis opportunities for players with disabilities. In 2024, athletes again represented Ireland at the International Blind Sports Association World Games, taking home two bronze medals, an MVP award, and setting records for the longest tie-break.

The continuation of the Sport for All Disability Supports Club Fund, in addition to the Local Disability Sports Fund, allowed for the disbursement of funding to affiliated clubs to enable them to initiate or enhance disability specific activities and build connections within their local communities through inclusive programmes.



FACILITIES AND RESOURCES

National Tennis Centre

The National Tennis Centre is still the only fully operational Tennis Ireland managed facility and given its great location and the combination of indoor and outdoor courts it is a key venue for yearlong promotion of tennis, a place where the local community can try tennis, performance and national level players come to further develop their skills, and a home to the Irish National squads.

As such, the National Tennis Centre is a key facility for Tennis Ireland to invest in and further develop. Areas we identified in 2024 as priority projects include redevelopment of the air dome over the 3 outdoor clay courts, upgrade of the indoor courts lighting system to LEDs, upgrade to the clubhouse area, upgrade to indoor courts playing surface and better visibility and promotion of the National Tennis Centre.

In 2023, with Dublin City Council's support
Tennis Ireland applied for the Community Sports
Facilities Grant, projects we applied for were the
redevelopment of the air dome over clay courts
and upgrade of indoor court lightning to LEDs. In
September 2024 we were awarded €178,962.00
for the projects in the National Tennis Centre. We
plan to schedule the works for these two projects in
September 2025 for the dome and June 2025 for the
LED lights.

Other funds received for National Tennis Centre in 2024 were from the Sport Ireland's Dormant Account Funding disability capital funding stream, where we made an application to improve the accessibility resources of the Centre, and we were awarded €40,000.00 for the projects we applied with.

Two new staff members have been added to the National Tennis Centre in 2024, Facilities Manager Valerija Krsak and Leisure Attendant John Leonard.

The operational emphasis for the National Tennis Centre was identification and development of standard operating procedures (SOPs) and updates to the existing ones. This was key to make sure all operations and processes in the Centre were standardized, staff was trained on them and clear on all the processes in the Centre. Before 2024 there were no existing SOPs in the National Tennis Centre, so creating them allowed for a much more streamlined operation of the Centre in bookings and payment management, class signups, maintenance reporting, daily handover procedures, emergency procedures, etc.

Besides providing a key venue for performance tennis in the greater Dublin area, the National Tennis Centre prides itself in developing adult and junior social tennis classes, that have gone from having 80 people sign up per term in 2023 to now having over 140 people sign up to the last term in 2024. The revenue for our classes was $\in 38,000.00$ in 2024 and we set a target of $\in 50,000.00$ for 2025. These classes allow us to introduce tennis to the local community on a grassroots level, get kids and adults playing tennis and giving them a game for their life.

Dundalk Tennis Arena

In a landmark project for Tennis Ireland as an organisation and for the development of tennis in Ireland, we have identified and signed a lease on a venue in Dundalk, County Louth.

In January 2024 Tennis Ireland signed a 20-year lease with DKIT Sport on the former Dundalk Ice Dome.

Once its open, the Dundalk Tennis Arena will be the first tennis specific indoor arena in Ireland, with 4 ITF accredited cushioned acrylic standard championship courts supplied by Plexipave, seating for 600 people on a mezzanine overlooking the courts, changing rooms, toilets, CCTV, player chillout area, parking area and other welfare facilities.

Tennis Ireland applied for the Community Sports Facilities Grant in 2023 for the Dundalk Tennis Arena. We were ultimately awarded €223,507.00 for this project.

Renovation and upgrade works are ongoing in the arena since January 2024, and we have earmarked June 2025 for laying of the courts and July 2025 as a potential timeline for opening of the Dundalk Tennis Arena.

This new state-of the art arena will house a variety of tennis programmes, planned, organised and led by Tennis Leinster and Tennis Ireland staff. The arena will provide the local community, schools, tennis clubs, provincial and national level players a place to experience the highest level of playing surfaces and to try tennis for the first time, enjoy social tennis or further develop their tennis skills. It will also give Tennis Ireland a venue for all levels of national, regional and international competitions, to showcase the development and investments in Irish tennis.

Sport Ireland Campus Tennis Courts

Sport Ireland Campus have started the project of developing and building two outdoor tennis courts on their Campus.

Tennis Ireland had an advisory role in helping Sport Ireland Campus determine the best playing surface for these two courts, making sure that they support the performance aspect and are ITF accredited, but also that they allow for the highest possible utilisation all-year-long, given the fact that they are outdoors.

NTC Adult Tennis Classes in November 2024

The playing surface on these courts will be PoraFlex porous acrylic sports surface for tennis, with ITF Pace classification of 2 (medium-slow) allowing for a high level of play quality. The surface has optimal cushioning with the bonus of high porosity, which makes it extremely useful in rainy climates, and allows for much higher utilisation all-year-long.

The two tennis courts on Sport Ireland Campus were earmarked to be open by February 2025, but due to delays in the building phase, the opening has been pushed back until June 2025.

These two courts will showcase a great opportunity for tennis clubs in Ireland, who are planning to upgrade their playing surfaces, to come and test the Poraflex surface and see how it performs.

Access Tennis

Sport Ireland's 2023 Irish Sports Monitor found tennis to be the no.1 choice for survey participants when asked what new sport they would like to try.

It is the strategic plan and vision of Tennis Ireland to make tennis the most played and easily accessed individual sport in Ireland by 2028. We want to break down barriers for anyone to play and take part in tennis. Ensuring we have enough facilities to do so is a key element in our Access Tennis initiative.

Given that most tennis clubs in Ireland have capped their memberships and have long waitlists for new members, Tennis Ireland has started looking at options to activate more than 1800 community tennis courts around the islands that our regional development officers have detected. These courts provide venues where we can activate new programmes, bring tennis to underdeveloped areas, allow the local communities to try tennis and members of the public to play tennis at all levels, all under one booking app, AceBook, that would allow management of any courts that we add to the Access Tennis initiative.

Throughout 2024 Tennis Ireland Development, Operations and Facilities departments have been working on creating a roadmap and planning out the development of Access Tennis, creating clear targets for each year until 2028.

Tennis Ireland and DLR County Council have reached an agreement where the pilot venue for Access Tennis would be Beckett Park in Dún Laoghaire. This location is ideal as it's located near a large housing estate, the venue has a clubhouse and 6 artificial grass courts. Aside from just activating the courts and running programmes on them, we want to get usage data for any court we activate through Access Tennis which we would feed back to the local councils, giving them valuable insights on court utilisation and leading to further investments and development of tennis courts.

We plan to activate the Beckett Park courts by mid-2025, with courts in Clarinda Park, Marlay Park following soon after, and Dundalk Tennis Arena, National Tennis Centre as well as Sport Ireland Campus tennis courts being added by end of 2025 to the Access Tennis initiative. Our target for 2025 is adding 40 courts around Ireland to the Access Tennis initiative.

PERFORMANCE DEVELOPMENT

National Performance Development Programme and National Camps

2024 started with another 16-week term for the National Performance Development Programme. The focus on physical development continued with more physical training blocks designed by Matt Little in early part of 2024. This area was further enhanced when MSc student in Athletic Therapy & Strength and Conditioning, Denis Ciuhat, joined the programme in February. The players enjoyed multiple on-court sessions throughout the term with international experts such as Matt Little, former world number 23 Guillermo Garcia-Lopez and Nikola Kuhn, who has a career high of number 174 in the world. The programme also welcomed nutritionist, Grace Miller, as she held a series of workshops for the players in the build up to the busy tournament season.

Tennis Ireland introduced an application process for the first time for the new NPDP term in September. Having received over double the amount of applications for the places available, the programme offered more training weeks, more on-court hours, more strength and conditioning hours, more international trips, coach support at international events in Ireland, exposure to international coaching experts, sports psychology sessions, strength and conditioning programme designed by Matt Little and implemented in person by Denis Ciuhat and regular physical testing throughout. Once player selections were made the coaching team held a parents information meeting in Fitzwilliam. In 2024 the players also went on group trips to Aizkraukle, Latvia and Vilnius, Lithuania.

Tennis Ireland held a total of 14 national camps in 2024 for under 10, 11, 12 and 14 players. Players got the opportunity to work with world leading coaches such as Simon Wheatley and Matt Little while training with the best players in their age group. The camps focus predominantly on tactical and physical components of training. Coaches were invited to attend the national camps as well as the coach education sessions that Matt and Simon provided in conjunction with the national camps. The feedback from players and parents regarding the national camps has been extremely positive and we look forward to further improving this offering going forward.

Regional Programmes

2024 saw the re-emergence of the Connacht programme. 38 players took part in the programme which continues to go from strength to strength into 2025. Leinster had a busy year with 151 in volved in the programme, while 78 and 37 players took part in the Ulster and Munster programmes respectively. In ------ Ulster and Leinster held a friendly match in Belfast. These events are always great days as they allow the players to get competitive match play while making new friends along the way. Leinster also travelled abroad to train at the Rafael Nadal Academy and in Murcia. A great experience for all the players and coaches

TI Junior Kids Programme

This vitally important programme went from strength to strength throughout the year. 1,217 players took part at regional events throughout the country in 2024 at red, orange and green ball level. Tennis Ireland also hosted 12 national events, culminating in the national tour finals in the National Tennis Centre in August.

Davis Cup

In February Ireland hosted Austria in a World Group I playoff tie in the UL Sport Arena, Limerick. Austria were heavy favourites going into the tie with former world number 3, Dominic Thiem and former world number 37 Sebastian Offner leading their charge. The tie started with Irelands Michael Agwi taking on Dominic Thiem. Michael started strongly and had set points in the first set, only to lose it on a tie break. Thiem's experience showed in the 2nd set, winning it 6-3. Overall, a very encouraging start for Michael and the Irish team. Next up was Osgar O hOisin versus Austrian number one, Sebastian Offner. Osgar started

well with his big serve and forehand dictating a lot of the points. Offner was also holding serve comfortably and the match had the look of a tight affair from the offset. So, it proved, with only a single break in each set, both going to the Austrian as he claimed a 6-4, 6-4 victory. Spirits were high in the Irish camp after day one with the doubles and reverse singles to come on day two.

The doubles match up saw Irelands Conor Gannon and Dave O Hare take on Austrias world no.33 ranked doubles team of Alexander Erler and Lucas Miedler. The Austrians started strongly taking the first set 6-1. The Irish pair settled early in the second set and were unlucky to lose out in a tie break. In the 4th match Michael Agwi went down 10-8 in the match tiebreak to Lucas Miedler after another extremely competitive match. All in all, the event was a huge success with almost 5,000 people watching world class live tennis for the first time in Ireland in many years.

In September the team travelled to Tunis, Tunisia for what looked like a tricky tie-on paper. The tie was a World Group II 1st round match and was played on red clay. Captain Conor Niland selected Michael Agwi to start proceedings versus Skander Mansouri. Michael played a very good match winning 7-6, 6-3 to give Ireland a 1-0 lead. Conor Gannon was next up against Aziz Dougaz, who has the highest ranking of number 185 in the world. Dougaz experience and know how on home soil proved too much for Conor on the day, resulting in a 6-3, 6-1 win for the Tunisian. The doubles tie was always going to be a close encounter between Conor Gannon and Michael Agwi of Ireland and Skander Mansouri and Aziz Ouakaa of Tunisia. Unfortunately, Ireland came out the wrong side of a 7-6, 6-3 scoreline leaving us trailing 2-1 going into the reverse singles.



Putting the disappointment of the doubles match to one side, Michael Agwi bounced back to produce a fantastic display against his higher ranked opponent, Aziz Dougaz, winning in straight sets 6-3, 6-4 to set up a 5th rubber decider between Conor Gannon and Skander Mansouri. Conor started strongly but 1 break of serve proved costly as he lost the first set 6-3. Mansouri got stronger in the 2nd set as he went on to wrap up the match and the tie, winning on a scoreline of 6-3, 6-1. A tough tie for the Irish team who will be determined to bounce back in 2025.

Billie Jean King Cup

Ireland competed in Euro group III in 2024. The event took place in Chisinau. Moldova and Ireland were drawn in group C with Luxembourg, Montenegro and Azerbaijan. Ireland started by beating Montenegro 2-1. Singles matches were shared with Sinead Lohan getting Irelands win before Celine Simunyu and Shauna Heffernan teamed up to win the tie for Ireland. Next up was Azerbaijan, who were dispatched comfortably 3-0. Celine and Sinead won their singles matches before Olwyn Ryan Bovey and Sarah Hawkshaw both debuted and won their doubles match on a scoreline of 6-0, 6-1. The 3rd and final match of the group pitted us against Luxembourg, the seeded team in our group. Sinead Lohan got Ireland off to a great start with a 6-4, 6-0 victory before Celine took down Luxembourgs number 1, Marie Weckerle, in 3 sets. Ireland rounded off the tie with a comprehensive victory in the doubles.

Ireland had qualified for the promotion playoff by Cyprus in our final playoff match. Eventual winners Cyprus proved too strong on the day, winning the tie 3-0. It was a positive week for our girls in green finishing 3rd out of 11 nations. We look forward to seeing their progress in 2025.

Player Performance

2024 saw Irish players flourish at home and abroad. Michael Agwi won four M15 singles titles in Oberhaching, Germany, Meerbusch, Germany, Antalya, Turkey and Grodzisk Mazowiecki, Poland. He also made the finals in Cadolzburg, Germany and Wroclaw, Poland. On the doubles court Michael also had success when winning in Antalya, Turkey. Celine Simunyu made the quarter finals at W15 Madrid and Melilla, Spain, Celine also had success on the doubles court, claiming 6 titles at the W15 events in Antalya, Casablanca, Mohammedia, Monastir, Madrid and Melilla. Tennis Ireland also supported Celine in gaining

topping group C. The promotion playoff would see us take on Cyprus and Finland. Sinead Lohan started the playoff with a fantastic victory over former world number 362, Laura Hietaranta. The Finns quickly levelled the tie when their number one player, Anastasia Kulikova, who is former number 192 in the world took down Celine Simunyu in a competitive singles rubber. The tie was decided by the doubles and unfortunately it wasn't to be for Irelands Shauna Heffernan and Celine as they lost in straight sets to their Finnish counterparts. The next day Ireland played a qualifying wildcard to the WTA 1000 event in Dubai, where competed well against top 100 player Christina Bucsa.

At junior level #homeadvantage again proved decisive for Irish players with no fewer than 19 players competing in ITF and Tennis Europe international finals in Ireland. Well done to winners Patrick Marsh, Rachel Deegan x2, Patrick Breen x2, Sam Irwin, Brody Lee Stafford, Laura Carvalho E Silva Kracke. There was also success on the doubles court with victories for James Lammas, Rachel Reid x2, Patrick Breen, David Somers x2. James Hatton. John McGarvey, Sienna McCarthy, Alicia Sutton, Scarlett Foley, Sophie McKenna and Brody Lee Stafford. Outside of Ireland Patrick Breen excelled with wins at the prestigious Kungens Kanna Super Category event in Stockholm, Sweden. Patrick won the doubles event with his partner Eric Lorimer, this was after the team won the Bolton Category 1 event in the UK. Patrick also won in Wrexham at the category 2 event and made the final of the category 1 event in Burgas, Bulgaria. Brody Lee Stafford also had success on foreign soil, winning the category 3 event in Stavanger, Norway.

Representative Teams

Ireland entered the Tennis Europe summer cups in 2024 as well as the European championships under 14. The highlight performances came from the girls under 16 team who defeated Portugal 2-1 and Belgium 3-0 and the boys under 18 team who defeated Great Britain 2-1. Ireland also hosted the Junior 4 Nations in Donnybrook Tennis Club. The under 14 team finishing 2nd in their section.

Ranking Highlights

Michael Agwi had a breakthrough year in 2024 jumping more than 700 positions from 1120 to finish the year at number 409. Conor Gannon and Freddy Murray also gained their first professional points in 2024 with victories at the Irish Open in Carrickmines. On the women's side Celine Simunyu also had a progressive year going from 1027 to 891. The standout ranking highlight in the junior section was Patrick Breen who had a best ranking of number 14 in Europe and was also number 9 in the race to Monte Carlo.

Anti-Doping

Tennis Ireland adopts the Sport Ireland Anti-Doping Rules which are compliant with the World Anti-Doping

The policy of Tennis Ireland is that doping is contrary to the spirit of FAIR PLAY and all players have a responsibility to ensure that tennis is free of doping.

In 2024 29 athletes completed the Sport Ireland Anti-Doping e-learning course. Further to this, 11 players selected for Davis Cup and Billie Jean King Cup (from fixtures in February, June and September) completed the ITF Anti-Doping course online.

All players, Ireland captains and coaches are made aware of the Sport Ireland medcheck website to check medications on a regular basis to ensure familiarity before and during competition. Prior to all Junior tours, information on Anti-Doping and Tennis Ireland's Anti-Doping policy is circulated to all parents to create more awareness and for players and parents.

Players are made aware of Anti-Doping updates from the Tennis Ireland Anti-Doping Officer as well as updates to the Tennis Ireland Anti-Doping Policy and changes due for the following year including prohibited substances and modifications to the Anti-Doping rules.

In 2024 14 samples were collected with no adverse findings recorded.

Education sessions are planned for 2025 for players aged 12-18 as well as plans to introduce Anti-Doping education for coaches as part of the Continuous Professional Development programme for 2026 from the WADA Adel platform to increase overall awareness, education and responsibility for those involved in tennis to ensure it is a clean sport.

DIRECTOR'S REPORT

For the financial year ended 31 December 2024

The directors present their annual report and the audited financial statements for the year ended 31 December 2024.

Principal activities

Tennis Ireland is a company limited by guarantee and without share capital. The company has a total of ten directors.

Tennis Ireland is the national governing body for the sport of tennis in Ireland. Founded in 1908, it has approximately 190 affiliated clubs and the combined membership of these clubs is estimated at 90,000 registered members with an additional 35,000 recreational players. Tennis Ireland stage various local, regional and national competitions, professional events and also competes in the Billie Jean King Cup, the Davis Cup and other international team-based tennis competitions. It also operates a variety of development programmes at local, regional and national level for players of all ages and abilities.

Tennis Ireland has five broad areas of responsibility as follows:

- Administration and regulating the sport at all levels;
- · Organising competitions at all levels;
- Developing the sport through the delivery of key development programmes at local, regional and national levels:
- The management and development of performance tennis through the National Tennis Centre at DCU together with the various national and provincial development programmes which support the initiative; and
- Promoting and advocating the sport to key stakeholders such as government and media

Results

The profit for the year, after taxation, amounted to \in 7,667 (2023 - \in 164,279).

Principal risks and uncertainties

Risk management is an important function of the board and the management team.

The board retains overall responsibility for managing risk and maintains a risk register, which it uses to actively manage key risks facing the organisation.

Key risks identified by the board include:

a reduction in participation in the sport, either in terms of playing numbers or affiliated clubs;

- inadequate funding from stakeholders (member clubs, government, etc.) or other commercial activities to support operations and strategic projects;
- inability to attract the requisite talent to enable the organisation to meet its objectives, and;
- non-compliance with governance, safeguarding, financial and regulatory best practices.

Risk identification, assessment and mitigation are considered by the board on an ongoing basis.

Accounting records

The measures taken by the directors to ensure compliance with the requirements of Sections 281 to 285 of the Companies Act 2014 with regard to the keeping of accounting records, are the employment of appropriately qualified accounting personnel and the maintenance of computerised accounting systems. The company's accounting records are maintained at the company's registered office at Tennis Ireland Building 2 Sport HQ2, National Sports Campus, Snugborough Road, Blanchardstown, Dublin 15.

Events since the end of the year

There were no significant events affecting the Company since the financial year end.

Future developments

The Company plans to continue its present activities to grow and develop the game of tennis on the island of Ireland.

Reserves Policy

The Board of Tennis Ireland CLG consider it prudent that sufficient net cash reserves should be maintained by the organisation, so as to cover the fixed overheads of the company for a period of up to 4 months. Net cash reserves are defined as gross cash balances held at any time less cash commitments for future committed grant payments or other funds held for future specific capital projects.

These Reserves are retained as cash and cash equivalents and are funds that are available to the organisation for future expenditure in exceptional times e.g. in the event of a major loss of operational income or other unexpected events.(e.g. COVID). The level of reserves required is regularly reviewed to ensure they are adequate to support the continuing obligations of the Organisation.

1. General information

Tennis Ireland CLG is a company Limited by guarantee, having no share capital and incorporated in Ireland (Registered number 342413) with a registered office at Tennis Ireland Building 2 Sport HQ2, National Sports Campus, Snugborough Road, Blanchardstown, Dublin 15. It is a registered sports body.

2. Accounting policies

2.1 Basis of preparation

The financial statements have been prepared under the historical cost convention unless otherwise specified within these accounting policies and in accordance with Section 1A of Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and Republic of Ireland and Irish statute comprising of the Companies Act 2014. The Company qualifies as a small company as defined by Section 280A of the Act, in respect of the financial year and has applied the rules of the 'Small Companies Regime' in accordance with Section 280C of the Act and Section 1A of FRS 102. The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires management to exercise judgment in applying the Company's accounting policies (see note 3) The financial statements are presented in Euro (€). The following principal accounting policies have been applied:

2.2 Foreign currency translation

Functional and presentation currency The Company's functional and presentational currency is Euros.

Transactions and balances

Foreign currency transactions are translated into the functional currency using the spot exchange rates at the dates of the transactions.

At each period end foreign currency monetary items are translated using the closing rate. Non-monetary items measured at historical cost are translated using the exchange rate at the date of the transaction and non-monetary items measured at fair value are measured using the exchange rate when fair value was determined.

Foreign exchange gains and losses resulting from the settlement of transactions and from the translation at period-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit or loss except when deferred in other comprehensive income as qualifying cash flow hedges.

Foreign exchange gains and losses that relate to borrowings and cash and cash equivalents are presented in the Statement of comprehensive income within 'finance income or costs'. All other foreign exchange gains and losses are presented in profit or loss within 'other operating income'.

2.3 Income

Income is recognised to the extent that it is probable that the economic benefits will flow to the Company and the income can be reliably measured. Income is measured as the fair value of the consideration received or receivable, excluding discounts, rebates, value added tax and other sales taxes. The following criteria must also be met before income is recognised:

Rendering of services

Income from a contract to provide services is recognised in the period in which the services are provided in accordance with the stage of completion of the contract when all of the following conditions are satisfied:

- the amount of income can be measured reliably;
- it is probable that the Company will receive the consideration due under the contract;
- the stage of completion of the contract at the end of the reporting period can be measured reliably; and
- the costs incurred and the costs to complete the contract can be measured reliably.

2.4 Pensions

Defined contribution pension plan

The Company operates a defined contribution plan for its employees. A defined contribution plan is a pension plan under which the Company pays fixed contributions into a separate entity. Once the contributions have been paid the Company has no further payment obligations.

The contributions are recognised as an expense in profit or loss when they fall due. Amounts not paid are shown in accruals as a liability in the Statement

of financial position. The assets of the plan are held separately from the Company in independently administered funds.

2.5 Taxation

The Company is exempt from corporation tax as a sporting body. The Company does not carry out its activities for gain and accordingly has not provided for corporation tax. The Company is in compliance with Circular 44/2006 'Tax Clearance Procedures Grants, Subsidiaries and Similar Type Payments'.

2.6 Tangible fixed assets

Tangible fixed assets under the cost model are stated at historical cost less accumulated depreciation and any accumulated impairment losses. Historical cost includes expenditure that is directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.

Depreciation is charged so as to allocate the cost of assets less their residual value over their estimated useful lives, using the straight-line method.

Depreciation is provided on the following basis:

National indoor training centre - 4.04% reducing balance

NTC clay courts - 25% reducing balance

Equipment, fixtures and fittings - 25% reducing balance

Hard courts - 8.33% straight line

The assets' residual values, useful lives and depreciation methods are reviewed, and adjusted prospectively if appropriate, or if there is an indication of a significant change since the last reporting date.

Gains and losses on disposals are determined by comparing the proceeds with the carrying amount and are recognised in profit or loss.

2.7 Termination benefits

Termination benefits are recognised as a liability and an expense only when the Company is demonstrably committed either: (a) to terminate the employment of an employer or group of employees before the normal retirement date, or (b) to provide termination benefits as a result of an offer made in order to encourage voluntary redundancy

2.8 Impairment of fixed assets and goodwill

Assets that are subject to depreciation or amortisation are assessed at each balance sheet date to determine whether there is any indication that the assets are impaired. Where there is any indication that an asset

may be impaired, the carrying value of the asset (or cash-generating unit to which the asset has been allocated) is tested for impairment. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's (or CGU's) fair value less costs to sell and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash flows (CGUs). Non-financial assets that have been previously impaired are reviewed at each balance sheet date to assess whether there is any indication that the impairment losses recognised in prior periods may no longer exist or may have decreased.

2.9 Valuation of investments

Investments in listed company shares are remeasured to market value at each balance sheet date. Gains and losses on remeasurement are recognised in profit or loss for the period.

2.10 Debtors

Short-term debtors are measured at transaction price, less any impairment. Loans receivable are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method, less any impairment.

2.11 Cash and cash equivalents

Cash is represented by cash in hand and deposits with financial institutions repayable without penalty on notice of not more than 24 hours. Cash equivalents are highly liquid investments that mature in no more than three months from the date of acquisition and that are readily convertible to known amounts of cash with insignificant risk of change in value.

2.12 Financial instruments

The company only enters into basic financial instrument transactions that result in the recognition of financial assets and liabilities like trade and other debtors and creditors, loans from banks and other third parties, loans to related parties and investments in ordinary shares. Debt instruments (other than those wholly repayable or receivable within one year). including loans and other accounts receivable and payable, are initially measured at present value of the future cash flows and subsequently at amortised cost using the effective interest method. Debt instruments that are payable or receivable within one year, typically trade debtors and creditors, are measured, initially and subsequently, at the undiscounted amount of the cash or other consideration expected to be paid or received. However, if the arrangements of a short-term instrument constitute a financing transaction, like the payment of a trade debt deferred beyond normal business terms or in case of an out-right short-term loan that is not at market rate,

the financial asset or liability is measured, initially at the present value of future cash flows discounted at a market rate of interest for a similar debt instrument and subsequently at amortised cost, unless it qualifies as a loan from a director in the case of a small company, or a public benefit entity concessionary loan. Financial assets that are measured at cost and amortised cost are assessed at the end of each reporting period for objective evidence of impairment. If objective evidence of impairment is found, an impairment loss is recognised in the Statement of comprehensive income. For financial assets measured at amortised cost, the impairment loss is measured as the difference between an asset's carrying amount and the present value of estimated cash flows discounted at the asset's original effective interest rate. If a financial asset has a variable interest rate, the discount rate for measuring any impairment loss is the current effective interest rate determined under the contract. For financial assets measured at cost less impairment, the impairment loss is measured as the difference between an asset's carrying amount and best estimate of the recoverable amount, which is an approximation of the amount that the Company would receive for the asset if it were to be sold at the balance sheet date. Financial assets and liabilities are offset and the net amount reported in the Balance sheet when there is an enforceable right to set off the recognised amounts and there is an intention to settle on a net basis or to realise the asset and settle the liability simultaneously.

2.13 Creditors

Short-term creditors are measured at the transaction price. Other financial liabilities, including bank loans, are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method.

2.14 Covernment grants

Grants are accounted under the accruals model as permitted by FRS 102. Grants relating to expenditure on tangible fixed assets are credited to profit or loss at the same rate as the depreciation on the assets to which the grant relates. The deferred element of grants is included in creditors as deferred income. Grants of a revenue nature are recognised in the Statement of comprehensive income in the same period as the related expenditure.

3. Judgments in applying accounting policies and key sources of estimation uncertainty

Preparation of the financial statements requires management to make significant judgements and estimates. The items in the financial statements where those judgments and estimates have been made include:

Useful lives of depreciable assets The annual depreciation charge depends primarily on the estimated lives of each type and component of asset and, in certain circumstances, estimates of fair values and residual values. The directors annually review these asset lives and adjust them as necessary to reflect current thinking on remaining lives in light of technological change, prospective economic utilisation and physical condition of the assets concerned. Changes in asset lives can have significant impact on depreciation charges for the period. It is not practical to quantify the impact of changes in asset lives on an overall basis, as asset lives are individually determined, and there are a significant number of asset lives in use. The impact of any change would vary significantly depending on the individual changes in assets and the classes of assets impacted.

Recoverability of debtors The Company has made judgments when assessing impairment of its debtors. Outstanding balances have been grouped on the basis of similar risk characteristics such as past-due status. Impairment has been reviewed with reference to historical loss experience updated for current conditions.

The Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media provided a capital grant in relation to the building of the National Indoor Training Centre via the Sports Capital Programme. Subsequent re-surfacing of the hard courts was also funded by the Department's Sports Capital Programme. Under these grant agreements, the Minister of Tourism, Culture, Arts, Gaeltacht, Sport and Media has a charge over the related assets of the Company. The re-surfacing of the clay courts at the National Tennis Centre also occurred and was funded by Dublin City Council and the International Tennis Federation (ITF). The construction of the Dundalk Tennis Arena got underway in 2024 with funding received during the year for this project from a non-state body third party benefactor. The grants are deferred and recognised in the income statement over the useful life of the related asset.

15. Company status

The company is limited by guarantee and consequently does not have share capital. Each of the members is liable to contribute an amount not exceeding \in 1 towards the assets of the company in the event of liquidation.

16. Capital commitments

The Company has entered into a contract for the building of Dundalk Tennis Arena, with an expected total cost of approximately \in 750,000. After donations and sports capital grant funding the expected commitment by Tennis Ireland is approximately \in 270,000.
